## ⇒ **MARSP LUNCHEON MEETING MINUTES**      **September 3, 2015**

The regular meeting of the Midland Association of Retired School Personnel was held on September 3, 2015, at 11:30 a.m. at First Baptist Church, President Ann Parish presiding. The invocation and flag salute were led by George Cooper. President Parish expressed her thanks to Anita Patton for handling lunch reservations, Orin Wade for providing piano music, and Deanna Dunn for the table decorations. President Parish welcomed all members and guests and introduced state leaders Maridell Fryar, Martha Kallus, and Michelle Cobb.

### PROGRAM:

Sheila Morrow introduced the guest speaker, Dr. Margaret Wade, Dean of Math, Science and Kinesiology at Midland College. Dr. Wade presented her program, Cultural Observations of a Biologist. She shared a slide show and her experiences while attending various festivals in the Mayan villages of Mexico. Sheila then presented Dr. Wade with a certificate of appreciation and informed her that a donation to the MARSP scholarship fund would be made in her honor.

### BUSINESS MEETING:

President Parish asked members to review copies of the May minutes that were on the tables for members to review. There were no additions or corrections, so the minutes were approved as printed.

President Parish introduced Patti Heard, who with Dorothy Baird will be publishing the newsletter. The newsletter will be delivered by email unless members specifically request regular mail. The deadline to request regular mail delivery is today, September 3, 2015.

Copies of the proposed 2015-2016 budget were placed on the tables for members to review. In the absence of Treasurer Mary Smith, President Parish discussed the proposed budget. It was noted that some items, such as ink and mailing supplies, may change because of the change in the number of newsletter mailings. The gift to First Baptist for food and maintenance will double. A motion to accept the budget was made by Maridell Fryar, second by Martha Kallus. The motion carried.

Dorothy Thompson presented the 2015 MARSP Scholarship of \$1500 to Skylar Knight. Skylar, a product of Midland schools, is a senior at UTPB and will be doing her student teaching in the spring before graduating in May. She has worked with the MISD AVID program and hopes to work with junior high students in the future. Dorothy also encouraged members to contribute to the scholarship fund.

### ANNOUNCEMENTS:

Michele Cobb announced that the 2015-2016 membership count stands at 305 and encouraged members to bring new retirees to the luncheons. Members who bring a guest who joins will have their names submitted for a drawing at the convention. Options for joining and paying dues were reviewed. Dues for MARSP are \$50.00 with \$35.00 going to state. If members choose Diamond Plus, the state will deduct its portion from the member's monthly check. President Parish then recognized first-time attendees and new retirees.

Sheila Morrow reported that 3652 books have been donated to the Children's Book Project. She also thanked Mike and Kathy Landrum for their donation of 601 books. Sheila reported that the books have been donated to various places, including High Sky, Midland Need to Read, Genesis Center, day-care centers, and Casa de Amigos. Jennifer Cooper reminded members to keep track of volunteer hours and their exercise for the monthly drawings. The drawings will begin at the October meeting.

President Parish reminded members to make reservations for the October meeting. Then with no further business, the meeting was adjourned at 1:18 p.m.

**November 2015 has been designated by the TRTA Board of Directors as Foundation Month. The purpose is to increase awareness of the Foundation, including recent accomplishments and goals for 2016.**

**In 2016, the Foundation's goals include:**

- 1. Award 15 \$500 student scholarships.**
- 2. Award 15 \$500 classroom assistance grants.**
- 3. Award at least \$15,000 in grants from the Area Helping Hands program.**
- 4. Provide \$10,000 to TASA as a sponsor of the Texas Teacher of the Year (TOY) program.**
- 5. Expanding the educational program, the Legacy Campaign, by providing scholarships to active teachers and recognizing public schools, raising awareness of the defined benefit plan and the value of being a member of TRS.**

## ⇒ LEGISLATIVE LIAISON:

The TRTA Legislative Committee is already in the planning stages to address issues between the 2015 session and the 2017 session that affect all retired teachers, not just TRTA members. The Committee will be contacting Senators and Representatives regarding three major issues:

- 1) TRS-Care – The funding approved by the Legislature in the 2015 session will keep benefits and premiums stable for the next two years, but TRTA will need to ask the Legislature for close to \$1 billion in 2017 to keep the program solvent. There is not enough income at the present time to fund TRS-Care due to rising healthcare costs

which includes the dramatic rise in prescription drug prices. TRS-Care is in need of a fundamental change in its funding structure.

- 2) Fighting for a cost of living adjustment – The committee will actively pursue a COLA in 2017 for those TRS annuitants that were not eligible four years ago.
- 3) Protecting the defined benefit plan – TRS was recently attacked by the Texas Public Policy Foundation stating that the defined benefit plans “run contrary to sound budgeting principles that stipulate that taxpayer-funded programs should be predictable, viable and not reliant upon gimmick or market conditions.” TRTA responded with an article in the *Fort Worth Star Telegram* but is well aware of the danger and pitfalls of groups like TPPF who want to strip teachers of their hard-earned benefits. Another major topic of discussion was voter turnout. With increased voter turnout by retired teachers, our influence on policy makers increases. Texas primary elections begin in March 2016. Please stay informed about all these issues. If you know a teacher who is not a member, please encourage them to join. There is power and influence in numbers!!!

Your morning espresso may do more than jump-start your day; it could also lower your diabetes risk, according to a recent study in *Diabetologia*. After examining the coffee habits of 123,733 people over a four-year period, researchers found that those who upped their daily java intake by more than one cup over their usual amount had an 11 percent lower risk of developing type 2 diabetes. On the contrary, people who decreased their coffee consumption showed a 17 percent higher risk.
